## **Lobbying and Political Contributions Policy**

(restated and revised December 16, 2025)

## **Purpose and Scope**

Teledyne Technologies Incorporated, together with its subsidiaries, companies, affiliates, and business units worldwide ("Teledyne"), is committed to participating in the political and public policy process in a responsible, ethical and legal manner. This policy addresses lobbying and political contributions made by and on behalf of Teledyne to ensure compliance with all applicable laws and regulations and Teledyne's Global Code of Ethical Business Conduct.

This policy applies to all Teledyne businesses and employees worldwide, and to all third parties conducting Teledyne business, acting on Teledyne's behalf, or otherwise representing Teledyne in some capacity.

## **Political Contributions and Lobbying Activities**

Teledyne funds cannot be donated to a federal candidate or a federal political action committee, or to any state, county, or local candidate or political action committee where prohibited by law. Subject to this prohibition, prior written approval from the relevant Segment President and the Chief Compliance Officer or delegate is required for any of the following by or on behalf of Teledyne: (i) political contributions (which may take the form of a direct or indirect contribution, gift, loan, advance, or deposit of money or anything of value) to a politician or political party or for any ballot measure ("Political Contributions"), and (ii) lobbying activities, meaning any contact with a government official for the purpose of influencing any official action such as legislation, regulations and policies ("Lobbying Activities").

All Political Contributions and Lobbying Activities by or on behalf of Teledyne must be made in accordance with all applicable laws, regulations, and disclosure and reporting requirements. Teledyne's Finance Department is responsible for ensuring such expenditures comply with government contracting rules, including applicable accounting restrictions. Teledyne strictly forbids any form of corruption in connection with its business activities anywhere in the world, including offering or making an improper payment to obtain or retain business or an unfair advantage in violation of applicable anti-corruption laws.

No Company funds or assets may be used, donated, or contributed for political activities or purposes. Accordingly, employees must not use any Teledyne facilities, supplies, equipment, or funds for any political activities, including engaging in such activities on Teledyne time. Further, employees may not make Political Contributions in the name of Teledyne. Employees also may not use the Teledyne name or any logos or other intellectual property to indicate or suggest that Teledyne supports or opposes any candidate or political issue.

However, the Company respects the right of its employees to voluntarily use their own resources to contribute to a candidate or cause of their choice on their personal time and with their personal funds, in accordance with the Company's Global Code of Ethical Business Conduct. The Company will in no way reimburse any employee for time, funds, or other assets donated by Teledyne employees for political activities or purposes.

## **Participation in Trade Associations**

Teledyne membership in any trade association that engages in policy outreach and public advocacy may subject Teledyne to disclosure or reporting under applicable lobbying regimes. Teledyne will comply with all applicable lobbying laws and report trade association activities, donations and memberships as required by such laws.
